



This information may be used in relation to an offence under any law of Canada or a province for the purposes of establishing or verifying the identity of an individual, or to establish or verify the identity of an individual whose identity cannot reasonably be otherwise established or verified because of physical or mental condition.

The information you provide to CIC will be stored in the Personal Information Bank (PIB) CIC PPU (039 and 055). If you are required to provide biometric information, your fingerprints shared with the RCMP will be stored in the PIB CMP PPU 030. Individuals have a right to protection of and access to their personal information stored in each corresponding PIB in accordance with the Privacy Act and the Access to Information Act. - · a valid email address.





Bank draft, cashier's cheque or money order

- Payment must be in Canadian or RMB dollars.
- Payable to "Consulate General of Canada"
- Print your name on the back of the financial instrument.
- Please ensure that the bank does not forward your financial instrument to this office.
- If payment is made by financial instruments in RMB dollars, the payee bank must be located in China.
- Payment in Canadian dollars must be drawn on a bank located in Canada.

<u>∧ Important:</u> Financial instruments have a **limited validity**. Ensure that your financial instrument is **not older than 3 months** when it reaches our office.

Applications from China submitted through the Visa Application Centre (VAC) in China

Consult the <u>VAC website</u> for information on submitting visa fee payments. Please note that in addition to the visa processing fee, a fee is charged to use the VAC. Consult the VAC website for information on VAC fees.
